

## Dice Dreams in Game Sweepstakes

### Official Rules

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

- 1. OVERVIEW:** The Dice Dreams x Candy Land Sweepstakes (“Sweepstakes”) consists of Twenty-five (25) separate drawings. Entry into each drawing is separate. Entry into one drawing is not entry into any other drawing. You may only enter one (1) time throughout the Sweepstakes Period. To enter, follow the quick and easy steps described in Rule 4 below, all of which are free.
- 2. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are 21 years of age or older. Employees and their immediate family members of SUPERPLAY Ltd. - 4. HOW TO ENTER:** During the Sweepstakes Period, complete all of the following steps to earn one (1) entry into the Sweepstakes:
  - a. Log into your free Dice Dreams account (“Account”) via the free Dice Dreams mobile game app (the “App”) which is available for free download via the App Store or Google Play on any iOS or Android mobile device.
  - b. Make sure you’ve reached at least Kingdom 2 in the App (for which no purchase is required).
  - c. Log in to your Account in the App, take a screenshot image of your Player ID on the Settings screen in the App and send that screenshot image by direct message to Cherry Pick Prizes <https://www.instagram.com/cherrypickprizes/> on Instagram during the Sweepstakes Period.

**IMPORTANT:** To locate your Player ID, log in to your Account in the App, click the Menu icon and then click the Settings icon. Your Player ID will be shown on the Settings screen below the Support icon.

You must complete all of the above free steps in entirety to receive an entry. If you do not already have an Account, follow the instructions in the App to create a free Account. Remember to log in to your Account for each of the above steps. Limit of one (1) entry per person/Account.
