

**Dice Dreams Birthday Sweepstakes**  
**Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

- 1. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and D.C., who are 21 years of age or older. Employees and their immediate family members of SUPERPLAY Ltd. ("Sponsor"), Brandmovers, Inc., d/b/a The A Team ("Administrator"), and each of their respective representatives, franchisees, parents, retailers, distributors, subsidiaries, affiliates, suppliers, advertising agencies, and persons living in the same household as such employees are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law. Sponsor reserves the right to verify the eligibility and all facts at any time, and all Sweepstakes entrants ("Entrants") agree to cooperate in any verification process/request.
- 2. SWEEPSTAKES PERIOD:** The Sweepstakes begins on February 15, 2026, at 12:00:01 AM Eastern Time ("ET") and ends on February 22, 2026, at 02:59:59 AM ET ("Sweepstakes Period"). The Sponsor's database clock is the official timekeeper for this Sweepstakes.
- 3. HOW TO ENTER:**
  - (a) **Mobile/Online Entry:** During the Sweepstakes Period, log into your free Dice Dreams account ("Account") via the free Dice Dreams mobile game app (the "App") which is available for free download via the App Store or Google Play on any iOS or Android mobile device. Earn entries into the Sweepstakes through in-game purchases such as: Scrolling offer, 6 box offer, 1+1 1+2 1+3, 1PO offer, 3PO offer. The number of entries available for each in-game purchase will be disclosed in the App. If you do not already have a Dice Dreams Account, follow the instructions in the App to create your Account. **IMPORTANT:** Accessing the App as a "Guest" will not enable you to receive entries into the Sweepstakes. You must log into App using your free Account to participate in the Sweepstakes. Limit of one hundred (100) entries received via Mobile/Online entry per person/Account.
  - (b) **Free Entry:** To enter for free, and without need to access or engage in activities in the App, during the Sweepstakes Period complete the form located at [Entry Form](#) with the requested information. Limit of one hundred (100) entries received via Free Entry per person/Account.

Any attempt to enter more than one hundred (100) times during the Sweepstakes Period by any means, including, but not limited to, use of multiple identities, email addresses, Accounts, or other means, may result in disqualification from this and any other promotional offerings by Sponsor. Sponsor will use the eight entries received, regardless of method. Entries earned via in-game purchases and entries earned via the Free Entry method will be treated equally. Use of any macro, bot, script or other automated means to submit entries is prohibited. No responsibility is assumed for lost, late, damaged, misdirected, illegible, incomplete, incorrect

In the event of a dispute over the identity of the Entrant in connection with an electronic entry, the entry will be deemed submitted by the authorized account holder of the e-mail address associated with the Account associated with the entry. Entrants irrevocably agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects. Potential winners will be notified using the contact information associated with their entry. If the winner notification is returned as non-deliverable, the potential winner may be disqualified, and an alternate winner may be selected. No liability is assumed for any winner notification that is lost, intercepted, returned as undeliverable, or not received by a potential winner for any reason. Failure to respond to any winner notification within five (5) days may result in disqualification and selection of an alternate winner. Failure to comply when requested may result in disqualification and selection of an alternate winner. Sponsor reserves the right to substitute prize for one of equal or greater value if the advertised prize becomes unavailable. Limit one (1) prize per person and per household. **6. ODDS:** Odds of winning depend on the number of eligible entries received, regardless of Entry Method.
