

DISNEY SOLITAIRE “FORTUNE SWEEPSTAKES” (the “Sweepstakes”)

OFFICIAL RULES (the “Official Rules”)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. VOID WHERE PROHIBITED.

1. **ELIGIBILITY:** The Sweepstakes is open only to persons who are at least 18 years of age, or the age of majority in their jurisdiction of residence if higher than 18 (including but not limited to 19 in South Korea) at the time of entry where legally permitted, worldwide. Employees and their immediate family members of SUPERPLAY Ltd. (“Sponsor”), and each of their respective representatives, franchisees, parents, retailers, distributors, subsidiaries, affiliates, suppliers, advertising agencies, and persons living in the same household as such employees are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law. Sponsor reserves the right to verify the eligibility and all facts at any time, and all Sweepstakes entrants (“Entrants”) agree to cooperate in any verification process/request.
2. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on September 30, 2026, at 6:00:01 AM Eastern Time (“ET”) and ends on October 5, 2026, at 06:00:00 AM ET (“Sweepstakes Period”). The Sponsor’s database clock is the official timekeeper for this Sweepstakes.
3. **HOW TO ENTER:**
 - (a) **App-based Entry:** During the Sweepstakes Period, log into your free Disney Solitaire account (“Account”) via the free Disney Solitaire mobile game app (the “App”) which is available for free download via the App Store or Google Play on any iOS or Android mobile device. If you do not already have a Disney Solitaire Account, follow the instructions in the App to create your Account. You must log into the App using your free Account and complete the tutorial phase within the App, meaning levels one (1) through nine (9) of the in-App game, to participate in the Sweepstakes. Entries into the Sweepstakes (referred to herein and in the App as “Tickets”) may be earned in any of the following three (3) ways: (i) by purchasing selected offers in the App that include Tickets; (ii) by spinning the Sweepstakes wheel in the App once during each eight (8) hour period of the Sweepstakes Period (each spin, a “Gameplay”), with each Gameplay awarding 5, 10, 12, 20, 65, 80 or 99 entries, as displayed on the wheel; or (iii) by collecting in-game Digital Rewards (“DRs”) in designated in-game events. The number of Tickets available for each such offer, and the number of Tickets that each DR collected entitles you to, will be disclosed in the App.
 - (b) **Free Entry:** To enter for free, and without need to access or engage in activities in the App, once per day during the Sweepstakes Period you may send an email to disneysolitaire-help@superplay.co with the subject line “Fortune Sweepstakes Email Entry” and the following information in the body of the email: User ID, request to enter without need to play or complete the tutorial phase. Each email sent entitles the Entrant to three (3) Gameplays, corresponding to the maximum number of daily wheel spins available via App-based Entry. The number of entries awarded for each such Gameplay will be determined by the same random means applicable to wheel spins in the App, and Sponsor will notify the Entrant of the number of entries awarded by email following the end of the Sweepstakes Period. Any additional form submitted by the same person on the same day will be void.

Limit of three (3) Gameplays per person/Account per day, whether via wheel spins in the App, Free Entry, or a combination of both. For purposes of these Official Rules, a “day” begins at 6:00:01 AM ET and ends at 6:00:00 AM ET the following calendar day. Any attempt to obtain more than fifteen (15) Gameplays during the Sweepstakes Period by any means, including, but not limited to, use of multiple identities, email addresses, Accounts, or other means, may result in disqualification from this and any other promotional offerings by Sponsor. Use of any macro, bot, script or other automated means to spin the

wheel or submit entries is prohibited. Entries earned through purchases made other than through the App's official in-App purchase functionality are void, and the Entrant may be disqualified. No responsibility is assumed for lost, late, damaged, misdirected, illegible, incomplete, incorrect entries or other sweepstakes materials, all of which are void, or for errors due to computer malfunctions, software errors, transmission problems or interruptions in operations.

In the event of a dispute over the identity of the Entrant in connection with an electronic entry, the entry will be deemed submitted by the authorized account holder of the e-mail address associated with the Account associated with the entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

4. **WINNER SELECTION AND NOTIFICATION:** Fifty (50) winners will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period, on or about October 12, 2026, at approximately 11:00 am ET.

Entrants irrevocably agree to be bound by these Official Rules and by the decision of the Sponsor, which are final and binding in all respects. Potential winners will be announced and notified within the App. No liability is assumed for any winner notification that is lost, intercepted, returned as undeliverable, or not received by a potential winner for any reason. Failure to respond to any winner notification, where needed, within five (5) days may result in disqualification and selection of an alternate winner. Failure to comply when requested may result in disqualification and selection of an alternate winner. If a potential winner is found ineligible, or if they have not complied with these Official Rules or decline a prize for any reason prior to award, such potential winner will be disqualified, and an alternate winner may be selected. Sponsor may require any potential winner to provide valid government-issued photo identification as proof of age and eligibility. Failure to do so may result in disqualification and selection of an alternate winner. Except where prohibited, participation in the Sweepstakes constitutes each winner's consent to Sponsor's use of their name, username, likeness and city/country of residence for promotional purposes in any media, without further compensation.

5. **PRIZES:** There is a total of fifty (50) prizes available -

- First Prize (1 available) – 10,000,000 coins
- Second Prize (1 available) – 2,000,000 coins
- Third Prize (1 available) – 1,000,000 coins
- Fourth Prize (47 available) – 500,000 coins

Coins are available for free via various actions in the App, and, accordingly, do not have a cash value.

Prizes are non-transferable and no cash equivalent or substitution of the prize is offered, except at the sole discretion of the Sponsor. Sponsor reserves the right to substitute prize for one of equal or greater value if the advertised prize becomes unavailable. Limit one (1) prize per person and per household. Winners are solely responsible for the payment of all federal, state and local taxes, and for any other fees or costs with acceptance or use of any prize.

6. **ODDS:** Odds of winning depend on the number of eligible entries received, regardless of method of entry.
7. **MISCELLANEOUS:** Sponsor is not responsible for any (a) lost, late, misdirected, damaged, garbled, incomplete or illegible entries, all of which are void; (b) telephone, computer, mobile device, hardware, software, programming or network malfunction or other technical failures or errors, or the failure to properly process entries; (c) communication disruption or other forces beyond the reasonable control of

the Sponsor, including but not limited to disruption related to internet traffic, wireless networks, virus, bug or non-authorized intervention; or (d) damage caused by a computer or mobile device related virus or otherwise resulting to any computer or mobile device from such person's participation in the Sweepstakes whether human, mechanical or electronic. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes, in whole or in part, if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other unintended circumstances have impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein. If the Sweepstakes is terminated before the end date, Sponsor will post a notice inside the App and, to the extent possible, winner(s) will be selected from among all eligible entries unaffected by any error that were received as of the termination date. Persons found tampering with or abusing any aspect of this Sweepstakes, or whom Sponsor believes to be causing malfunction, error, disruption, or damage will be disqualified. Entries that contain errors or are incomplete or received after the relevant entry period, will not be accepted.

8. **RELEASE OF LIABILITY:** By participating, each Entrant releases Sponsor, Disney Interactive ("Disney"), and each of their respective parent companies, subsidiaries, affiliates, partners, employees, directors, agents, advertising and promotional agencies, and all other persons and entities associated with the development and execution of the Sweepstakes ("Sweepstakes Entities") from any and against any and all injury, loss or damage caused or claimed to be caused by their participation in the Sweepstakes and/or the acceptance, awarding, receipt, use and/or misuse of any prize, and each Entrant agrees that the Sweepstakes Entities are not responsible for any warranty, representation, or guarantee, expressed or implied, in fact or in law, relating to the Sweepstakes and/or the awarding of any prize except as expressly provided in these Official Rules. Except where prohibited, by participating, each Entrant agrees that: (a) any and all disputes, claims, and causes of action arising out of or in connection with the Sweepstakes, or any prizes awarded, shall be resolved individually without resort to any form of class action, and exclusively by the United States District Court for the District of Delaware or the appropriate Delaware State Court located in Wilmington, Delaware U.S.A; (b) any claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorney's fees; (c) under no circumstances will any Entrant be permitted to obtain any award for, and each Entrant hereby waives all rights to claim, punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses; and (d) these Official Rules and all disputes shall be governed by, and construed in accordance with, the laws of the State of Delaware, without regard to principles of conflicts of laws (whether of the State of Delaware or any other jurisdiction) which would cause the application of the laws of any jurisdiction other than the State of Delaware.

Entrants acknowledge and agree that by participating in the Sweepstakes and providing any personal information, subject to applicable law, Sponsor may collect and use such personal information provided for the purposes of conducting the Sweepstakes and as otherwise permitted in Sponsor's referenced privacy policy.
